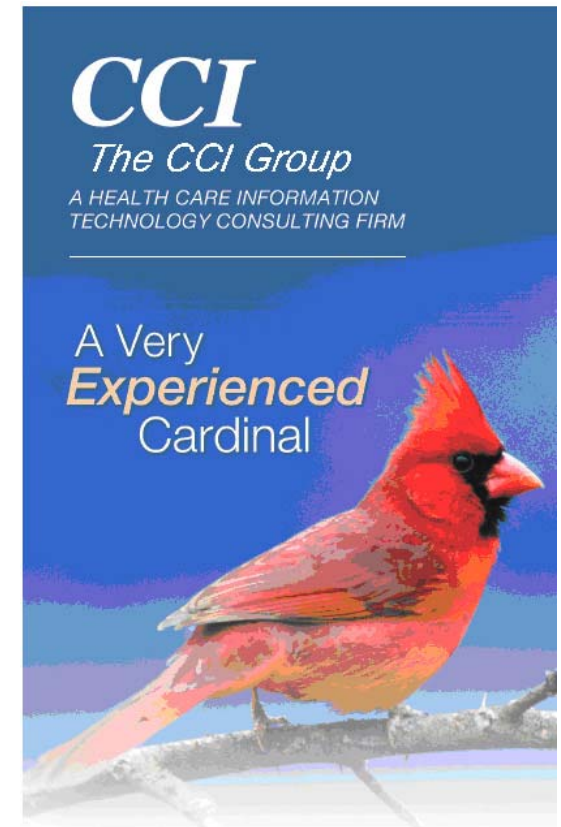

The demand for health care information technology is nearly endless. However, that demand must be balanced within an organization's economic realities and its ability to absorb change. The desire by senior leadership to remain abreast of important new information technologies, while gaining the most from those already committed, is a challenge that causes many health care organizations to employ a Chief Information Officer (CIO).

In some circumstances a knowledgeable and experienced CIO is difficult to attract at an acceptable salary. CCI has developed the Retained Executive CIO Service to provide CIO services on a part time retainer basis.

The CCI Executive CIO Service starts with an initial assessment of the organization's use of information technology. This initial assessment serves as the basis for subsequent on-site and telephone support to address significant IT needs.

We have found that the organizational requirements for a successful Executive CIO include:

1. Organizational Fit
2. Knowledge and Experience
3. Affordable Cost

Here is how we address each of these requirements:

1. Organizational Fit

The best way to make the right choice of the CIO resource for you is to meet and work with that person in your environment. CCI accomplishes this by beginning each project with an on-site review of your current circumstance including a review of staffing, technologies, infrastructure, applications, plans and management expectations. We will interview senior and IT management, selected department leadership and vendor resources if appropriate. 2. Knowledge and Experience
